MOE CUP

We have been alerted to the government Gazette where the Andrews Government has decided that Melbourne Cup day will not be a public holiday for those in the 3825 postcode. Instead, it will be replaced in the relevant post code by a public holiday on the Moe Cup Day.

Below is a copy of the Victoria Government Gazette.

Given that most agreements stipulate that Melbourne Cup is a public holiday the result for providers will be that there is now two public holidays. Removing the Melbourne Cup holiday from the Victorian Public Holiday list does not remove it from the EBA.

It is possible this will be an approach taken for local events such as the Geelong Cup. This may be an issue to be addressed where you are yet to finalise your EBA if there is a local event of significance where your facility is.
